## See a Year of Pension Benefits – With Just One Click

This handy resource gives you a wealth of information about your retirement benefits from the Fund. We recently added to the website valuable new features for both active and retired members.



The **NRIPP Annual Benefit Statement** is available to all active members. With just a few clicks of the mouse, you can view, download and print a full accounting of your hours with each participating employer and the pension contributions they made toward your benefit, on a month-by-month basis.


Your annual benefit statement is a valuable tool for your personal financial security needs. You may, for example, need to show it to a landlord or banker as proof of your work history when you find a place to live or apply for a loan. And in the case of a divorce or other change in your family, the easy access to an annual benefit statement can save you money on legal fees.

If you are a retired member and receiving a monthly benefit from the NRIPP, you may now download a copy of your **IRS Form 1099R**. This is the form you file with your income tax return to show the amount you received in benefits during the year. The administrators send you this form each year, but now you can download another copy any time you need one.

### How to Download Your Annual Benefit Statement or Form 1099R



When logging in to the NRIPF website, **active members** will see this screen with their personal information. From the menu on the left, click on the “Annual Benefit Statements” link.



The next screen shows the annual benefit statements available to you. Today only your 2009 benefit statement will be listed on this page. To download your statement, click on the “Select” button. In most cases, your annual benefit statement will open in a new window or tab.



Your computer's security settings may direct your annual benefit statement to be downloaded to your hard drive. If this happens, go to your "Downloads" folder to open the file named "AnnualBenefitsStatementForm." The file will be in the Adobe Acrobat (.pdf) format. Double-click on that file icon to open the statement on your screen. You may print the file or attach it to an e-mail.





Your Form 1099R for 2010 is the only form available today. In most cases, your Form 1099R will open in a new window or tab when you click on "Select."

Your computer's security settings may direct your Form 1099R to be downloaded to your hard drive. If this happens, go to your "Downloads" folder to open the file named "1099R\_Participant." The file will be in the Adobe Acrobat (.pdf) format. Double-click on that file icon to open the statement on your screen. You may print the file or attach it to an e-mail.
